Classic Stone Limited reserves the right, before having any obligation under this 30 year product warranty, to inspect the damaged Classic Stone Limited product, and if required all costs of shipping the Classic Stone Limited product to Classic Stone Limited for inspection shall be borne solely by the purchaser.

In order to recover a claim under this 30 year product warranty, the purchaser must make claim to Classic Stone Limited within 60 days of occurrence, and must present acceptable proof of original ownership (such as original receipt, warranty certificate, registration, on-line registration, or other documentation Classic Stone Limited deems acceptable) for the product.

Classic Stone Limited, at its option, shall repair or replace the defective product covered by this warranty only if the product has been handled and installed by an approved and authorised Classic Stone Limited installer and only as prescribed in the instructions accompanying this warranty enclosed. Also there must be no attempt to alter or repair the original Classic Stone project without the written consent of Classic Stone Limited and the owner assumes all risks and liability for the use of Classic Stone with other building materials not specified in its installation instructions.

No Statement by any employee of Classic Stone Limited directly or indirectly admitting liability under this warranty shall be binding unless made in writing by an authorized officer of Classic Stone Limited.

This 30 year limited warranty does not cover any damage due to accident, misuse, abuse or negligence including

- Settlement of the building or other walls or foundation movement.
- Discolouration or damage due to contact with Chemicals, Paint, Staining, and/or oxidation.
- Steam Cleaning or Water Blasting.
- Not following the Management and Maintenance requirements.
